



Town Council Meeting Items – February 21

- Recognition of retiring Town Manager Daniel C. Holler.
- Town Council will review and provide comments on the proposed Amendment to the 2010 Snowcreek Development Agreement.
- Town Council will hold a Public Hearing under the Tax and Equity Fiscal Responsibility Act ("TEFRA") in connection with the proposed issuance of revenue bonds by the California Municipal Finance Authority (the "CMFA") for The Sawyer and The Parcel Phase 2.2 Apartment Affordable Housing Projects.
- Town Council will consider proposed funding support for the Mammoth Lakes Mosquito Abatement District.
- Town Council will consider approval of the Town of Mammoth Lakes and Mono County Whitmore Recreation Area Joint Operations and Maintenance Agreement.
- Town Council will consider the adoption of a resolution approving the form and authorizing execution of certain lease financing documents in connection with the offering and sale of certificates of participation relating thereto to finance the cost of construction and equipping a new town facility and the cost of acquiring certain land and improvements and authorizing and directing certain actions with respect thereto.

New Parking Policy at Mammoth Yosemite Airport

Eastern Sierra Current Precipitation Conditions

- LADWP hydrographers conducted the first snow surveys and measurements of the year, bringing back the news that the atmospheric river (as of 2/6) brought 25% of an average year's snowfall in less than a week of storms! The precipitation from the February 4 storm is on trend with the highest day totals from the January and March storms of 2023.
- **As of February 13, 2024**, LADWP Eastern Sierra Current Precipitation Conditions reported:
 - 12.1" of water content
 - 71% of normal to date
 - 54% normal of a typical water year ending April 1
- Continuing monthly through April 1, LADWP's snow surveys and Mono Lake staff gauge measurements will show how the February storms and historically unpredictable March precipitation nicknamed "Miracle March" will affect spring and summer water runoff and water supply projections for the Los Angeles Aqueduct.

Be Snow Smart by Observing a Few Simple Rules:

- Children should not play in yards, build snow forts or dig caves near the road during snow removal operations.
- When chain control conditions are in effect, the maximum speed limit throughout town is 25 mph.
- It is a violation of the Town's municipal code to park on any roadway from November 1 through April 30.
- When clearing your driveway, do not place snow in the roadway or on the Town's snow storage easement (10ft.-wide area immediately abutting the pavement edge). All snow must be stored on your property!
