INTRODUCTION

DANIEL C. HOLLER, TOWN MANAGER

2022 represented the first full year of recovery from the COVID pandemic. The Town saw increased levels of visitation, solid financial gains, and re-vitalization in local business. The Town refocused on core priorities to address housing needs, capital investment in infrastructure, and cooperative initiatives to improve recreational amenities.

Housing continued to be a major priority for the Town Council, with construction on Phase One of The Parcel making significant progress in 2022. The Town partnered with Mammoth Lakes Housing to acquire the Innsbruck Lodge, which will be converted into 16 apartments. The Town also developed pre-engineered and approved Accessory Dwelling Unit (ADU) plans that are available to the public free of charge for use in the Town and Mono County. The Town's Housing Now! initiative was successful in the purchase and resale of six condos at an affordable price under the Town's "Bridge Program." Additional units were also purchased to assist Town employees with interim housing.

The Town had another productive year on the recreation front. The Town's newest department, the Office of Outdoor Recreation (OOR) was created and includes three full-time positions along with seasonal part-time positions (trail crew and hosts). Trail maintenance and new trail development in the Lakes Basin took place. The winter grooming program for cross country skiing was also enhanced. The OOR also worked to increase stewardship and volunteer opportunities throughout the Mammoth Lakes area, with programs and projects implemented in partnership with Mammoth Lakes Recreation.

Work on the Community Recreation Center (CRC) continued, with an expected completion date of fall 2023. The Town entered an historic partnership with

the National Hockey League team the LA Kings to brand the Town's new ice rink as "LA Kings Ice at Mammoth Lakes," which is part of the CRC. The CRC will also operate as the "Mammoth Rec Zone."

The Town's Capital Improvement work was in full force once again this year, with numerous Capital projects being completed and ongoing. The Town rehabilitated the ballfields at Whitmore Recreation Area and completed road rehabilitation and maintenance projects throughout town. Work was done on the Town's fuel tanks to ensure clean and safe operations for years to come.

The Town continues to work to enhance municipal services. The Police Department was able to implement several new initiatives, including the purchase of a drone to assist with response to calls and was awarded several grants to support other programs. In partnership with Mono County, the Town launched its READY Mono Emergency Preparedness Portal. The Town also worked closely with Mammoth Disposal to ensure the new solid waste transfer station was operational prior to the closure of the Benton Crossing Landfill at the end of the year.

This report provides additional details on these and other accomplishments. We are proud of all that was accomplished in 2022 and look forward to another productive and successful year in 2023.

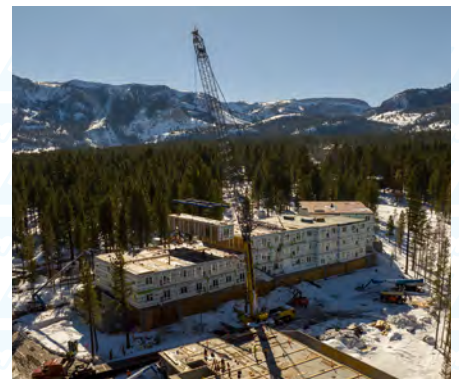
THE PARCEL CONSTRUCTION UPDATE

Construction at [The Parcel](#) resumed in full force in mid-2022 with construction of building foundations and the second floor post-tensioned concrete podium, underslab building utilities, and installation of public utilities (water, sewer, storm drain) along the new Inyo St. and extension of Tavern Rd.

The project reached a major milestone at the end of 2022, with placement of approximately 100 prefabricated building modules onto the second floor podium of both buildings, topping out the buildings at their final four-story height. The buildings were further weather-proofed to allow ongoing interior construction of utilities and finishes throughout the winter months. Installation of structural steel framing for the single-story childcare center and community space at the south side of Building A is underway. Further site work, including installation of dry utilities, roads and sidewalks, will also continue in 2023.

Phase Two of The Parcel, aka “The Sawyer” includes 81 apartment units within two buildings, at several affordability levels and with a variety of unit sizes between studio and three bedroom, as well as a community space, childcare facility, and a public park. Units are expected to be available for occupancy toward the end of 2023.

TOWN RECEIVES \$74.9 MILLION IN HOUSING GRANT AWARDS!

Pacific West Communities, Inc. was awarded \$38,656,617 for Phase One of The Parcel affordable housing project as a part of the California Housing Accelerator grant program. The California Housing Accelerator program is a \$1.75 billion investment to provide bridge funding to shovel-ready projects that were otherwise unable to begin construction because of a shortage of funding. In addition to the Housing Accelerator award, The Parcel project has been awarded an additional \$25.2 million from various grant programs to facilitate the construction of the infrastructure and Phase One of the project.

Separate from The Parcel, \$10.9 million was awarded for two partnership projects with Mammoth Lakes Housing, Inc. (MLH). These include the Innsbruck Lodge project and the Access Apartments project, an adaptive reuse project that aims to provide 11 affordable apartments.

PRE-ENGINEERED AND APPROVED ACCESSORY DWELLING UNITS

The Town, working with Mono County, has pre-engineered and approved Accessory Dwelling Unit (ADUs) plans for the public to utilize free of charge. The intent of the approved ADU designs is to make housing more affordable by greatly reducing the cost of design work for building plans. The designs are pre-engineered to conform to both structural and non-structural building code requirements, in

addition to Energy Code compliance documents. There are a total of five designs that range from 440 square feet to 1,000 square feet and are comprised of two two-bedroom units, two one-bedroom units, and one studio unit. The plans are now available to the public for free and are located on the Town's Building Division's website.

MAMMOTH LAKES HOUSING, INC. ACQUIRES INNSBRUCK LODGE FOR COMMUNITY HOUSING

On August 4, 2022, Mammoth Lakes Housing, Inc. (MLH) closed escrow on the Innsbruck Lodge with the intent to convert the boutique hotel into 16 affordable apartments that will target those who are homeless or at-risk of becoming homeless. Tenant occupancy will occur before the end of 2023. This acquisition is the result of a joint grant awarded to the Town of Mammoth Lakes and MLH for \$4.56 million through the Project Homekey program. The Mono County Board of Supervisors also made a financial commitment of \$550,000 and the Town has committed \$1.4 million to the project.



HOUSING NOW!

The Town's Housing Now! initiative is focused on programs expanding the availability of affordable workforce housing in the community. The program includes purchasing existing housing units and selling them to local qualified residents at affordable prices, expanding options for affordable rental units, continued support for The Parcel development, and securing property for near term new affordable housing projects. The program began in 2021 and continues to grow and provide creative housing solutions to our community.

BRIDGE PROGRAM

The Town, together with Mammoth Lakes Housing, Inc. (MLH), launched the Bridge Program in late-2021 with the goal of increasing the number of affordable deed-restricted ownership units in the community through the acquisition of market rate units that are then resold to individuals at a subsidized rate with a deed restriction in place to ensure they remain in the affordable housing stock for the Town. Since the program was launched, six units have been acquired, of which five have been resold to eligible households. Proceeds from the sale of these units are placed back into the program to facilitate the acquisition, and future subsidized sale, of additional units. The goal of the program is to add 12 additional deed-restricted units to the inventory of deed-restricted units within the Town.

SMALL-SITE DEVELOPMENT

The Town acquired the vacant 0.2-acre site at 60 Joaquin Rd. in the Sierra Valley Sites in summer of 2021 with the goal of developing four for-sale units that will be available to households earning up to 150% of the area median income (AMI). Since acquisition of the site, the Town has gone through a procurement process to bring on a design-build entity and is working with that entity on the design and project entitlements. The project will be reviewed by the Town's Planning and Economic Development Commission in 2023 and construction is tentatively scheduled to begin in 2023 with a target occupancy date in 2024.

Utilizing this concept, the Town continues to look for additional infill sites that would allow for additional units to be built, pending the availability of funding.



RECREATION ACCOMPLISHMENTS



OFFICE OF OUTDOOR RECREATION

The Office of Outdoor Recreation (OOR) was created in 2022, to help assist the Town in accomplishing a number of its goals related to outdoor recreation and interfacing with public lands. The newly formed OOR is tasked with providing accessible, sustainable, and high-quality recreational opportunities for community members and visitors with a specific focus on the interface of Town and adjacent public lands. The OOR leverages voter approved Measure R and U funding to maintain and enhance trails and other recreational infrastructure while implementing the necessary stewardship mechanisms to ensure enjoyment by future generations. The OOR has a permanent staff of three along with seasonal trail maintenance and trail host staff. The OOR is responsible for project management, stewardship programs, long range planning, trail maintenance and construction, winter grooming, and coordination and support with our Inyo National Forest Partners.



WINTER GROOMING

Office of Outdoor Recreation staff provide winter grooming services in both the Shady Rest area and at the base of the Sherwins. In total, OOR staff groom 3.4 miles of trail in the Shady Rest area and another 1.8 miles in the Sherwins. A proposal was submitted to the Inyo National Forest to expand the grooming program to further increase the opportunities for residents and visitors. This request will go through the Over Snow Vehicle (OSV) Subpart C process which will determine the future of how motorized recreation will be managed on Inyo National Forest lands. The Town will serve as a cooperating agency in this Subpart C effort and continue to engage in this important process.

SHERWINS TRAILS PLANNING AND TRAILHEAD IMPLEMENTATION SIERRA NEVADA CONSERVANCY GRANT

In partnership with Mammoth Lakes Recreation (MLR), a Sierra Nevada Conservancy grant totaling \$1,464,010 was received to develop a formal Sherwins Trailhead and to perform environmental analysis on approximately 20 miles of multi-use single track trails at the base of the Sherwins. OOR staff continue to work with Inyo National Forest specialists to move the environmental analysis forward and have hired archaeological consultants to perform heritage survey work in the field.



LAKES BASIN TRAIL DEVELOPMENT AND CONSTRUCTION

During summer 2022, the ORR completed design and development of three new multi-use single track trails in the Mammoth Lakes Basin with a fourth in the final stages of construction. Completed trails encompass 1.6 miles with another 0.9 miles nearing completion. These trails feature a sustainable design which will limit maintenance and environmental impact and provide further opportunities for residents and visitors to enjoy Mammoth's beautiful backyard. A ribbon cutting for the three completed trails was performed in October 2022.

HOST PROGRAM AND STEWARDSHIP

The Town and the Office of Outdoor Recreation continue to place a priority on ensuring the sustainability and longevity of our natural environment for future generations through a variety of stewardship programs. The summer Trail Host program continues to provide information, collect data, and help residents and visitors have fun safely. Summer 2022 reporting included 14,900 interactions with the public, over 2,000 pounds of trash collected, and over 600 pounds of dog waste removed from trails and recreation facilities. Trails Days began on June 4, 2022, in celebration of 'National Trails Days' and weekly volunteer opportunities were available through September, which allowed the public to volunteer for Trail Crew,

Trail Host, and the new Water Host positions. Trail Days data included 311 Trail Crew and Lakes Basin Cleanup volunteer hours, 30 Trail Host volunteer hours, 15 Water Host volunteer hours, 1.5 miles of new trail construction in the Lakes Basin, Trail maintenance on Mountain View Trail, and 375 pounds of trash removed. Other Town cleanup programs include town cleanup day in May and weekly "Trashy Thursday" events from June – August. Trashy Thursdays reported 177.5 volunteer hours, 1,576 pounds of trash and 15.5 pounds of dog waste removed. The Eastern Sierra Adopt a Trail program grew over the 2022 summer hosting a total of 23 volunteer adopters and 19 sponsors. This program is a partnership between Mammoth Lakes Recreation, Mono County and the USFS.



SHADY REST DISCGOLFPARK® RIBBON CUTTING CEREMONY

We finally got to celebrate the opening of the Shady Rest DiscGolfPark on May 24, 2022. Thank you to the Town Council, Parks and Recreation Commission, Mammoth Lakes Recreation (Measure R funded special project), the Mammoth Ranger District

of the Inyo National Forest, and the Mammoth Lakes Disc Golf Club for championing the project and working side-by-side with Town staff to install this professionally designed, PDGA sanctioned 18-hole disc golf course at Shady Rest Park.



CLEAN AIR GRANT FUNDS NEW ZERO EMISSION ZAMBONI MACHINE FOR COMMUNITY RECREATION CENTER

Funded from the Clean Air Projects Program, in February 2022 the Town took possession of a new lithium-ion Zamboni 552AC ice resurfacing machine for operation at the new Community Recreation Center. The Zamboni 552AC machine will deliver clean ice and clean air – critical for operating indoors at LA Kings Ice at Mammoth Lakes. The new emission-free ice-resurfer replaces the existing propane-driven 27-year-old Olympia, well past its useful life. The Town also purchased a new electric Zamboni EZIII Edger, replacing the outdated, gas-driven 1999 unit. The new Zamboni machine was used at the existing Mammoth Ice Rink for the remainder of the 2022-23 winter season.



LA KINGS ANNOUNCE HISTORIC NEW ICE RINK PARTNERSHIP

The Town of Mammoth Lakes, Mammoth Lakes Tourism (MLT), and Mammoth Lakes Recreation (MLR) have launched an historic new, community-driven partnership with National Hockey League (NHL) franchise, the LA Kings. As part of the expansive, multiyear partnership, brokered by AEG Global Partnerships, the partners have teamed up to launch LA Kings Ice at Mammoth Lakes – the Town’s first indoor Olympic-sized ice rink. The forthcoming LA Kings Ice at Mammoth Lakes will operate within a newly constructed, multi-use Community Recreation Center (CRC) that is set to open to the public in 2023.

For more than 20 years, Mammoth Lakes has been actively searching for a permanent home for an indoor ice rink and multi-use facility – one that would enhance the quality of life for residents and visitors with year-round access to high-quality and innovative indoor recreational program offerings and activities. This transformational partnership will bring the Town’s long-awaited vision to life and is a demonstration of the partners’ mutual support and commitment to the health and well-being of the community as well as the growth of hockey and ice sports in the region.



Broad community input from local residents and industry experts alike helped inform and build the programming playbook for LA Kings Ice at Mammoth Lakes. Based on this feedback, daily drop-in or frequently programmed on-ice activities at the facility will include public skating, youth and adult hockey, figure skating, and learn to skate lessons as well as the expanding curling program. The rink will also serve as the home of Mammoth Lakes Youth Hockey and the Mammoth Stars. Mammoth Lakes Youth Hockey is an all-volunteer and USA Hockey-sanctioned program providing in-house and travel hockey for the youth of the greater Eastern Sierra region.

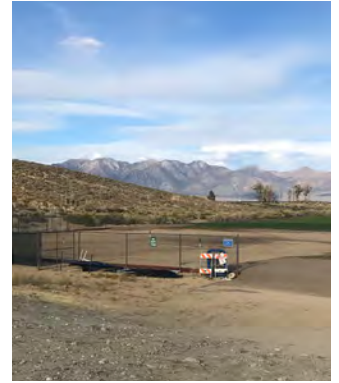
CAPITAL INFRASTRUCTURE ACCOMPLISHMENTS

PUBLIC WORKS DEPARTMENT PROJECTS

It has been another busy year on the Capital Improvement front. Our teams have been busy overseeing numerous short-term and ongoing projects. Some highlights include:

WHITMORE BALLFIELD REHABILITATION

The contractor began work on the Ballfields Rehabilitation project on August 18. New sod was installed to change the infield size to meet Little League and High School softball regulation field dimensions. The contractor placed 300 yards of decomposed granite to raise the infield and provide a buffer between the existing, degraded infield mix and the new infield mix. The installation of the new home run fence was completed in the spring of 2023.



ROAD AND MUP REHAB (CONTINUED FROM 2021)

The contractor returned to town on July 5 to finish the remainder of their contract work, including the installation of detectable warning pavers and bollards on multi-use paths, and the reconstruction and repaving of Mountain Blvd. and sections of Majestic Pines Dr. and Monterey Pine Rd. This work was performed in conjunction with AmeriGas's installation of new lateral lines along Majestic Pines Dr. and Monterey Pine Rd. The work was completed on September 2.



BLUFFS SLURRY SEAL PROJECT

The contractor completed the slurry seal resurfacing of the Bluffs roads on August 2. The slurry seal, which is an asphalt emulsion with fine aggregate, put a new finish on Fir St., Le Verne St., Benz Way, and Pine St. to help prolong the life of these roads by many years. After the slurry seal was placed, the contractor returned to paint, stripe, and clean the project area.



FUEL ISLAND AT PUBLIC WORKS YARD

In mid-October, the contractor was on site to inspect and clean the Town's underground tanks. This process included pumping out any contaminants built up in the tanks, interior sandblasting, and documenting tank conditions with photographs and ultrasounds. The tanks were found to be in good condition so a tank liner was installed. Separately, consultants are working on a design and bid package for a new slab with waterproof manholes. The existing slab will be removed and replaced. This work will be done in the summer of 2023. This remediation work will provide a minimum of 10 years of additional useful life from the existing fuel island.

COMMUNITY RECREATION CENTER PROGRESS

The sprung structure arrived at the end of April and install began in May, along with underground utilities. The structure is up, insulation installed, and mostly closed up. Interior framing, gas, water, electrical, and HVAC were being installed inside the building. Exterior paving was installed around the north and south sides, along with the parking lot and bus shelter. Opening is expected to occur in 2023.

TOWN COUNCIL APPROVES TWO PUBLIC-PRIVATE AGREEMENTS WITH MAMMOTH LAKES FOUNDATION

Creative planning work between the Town and Mammoth Lakes Foundation (MLF) resulted in joint efforts to expand community services and programs. The Town agreed to lease the Edison Hall in working with MLF to achieve the reopening of the Edison Theatre. MLF plans to remodel Edison Hall were initiated with a design that will support the future construction of a new 250 seat performing arts auditorium connected to a remodeled Edison Hall. The Town is providing operating support for the existing Edison Theatre and support for the proposed facility. Joint land use planning efforts to meet additional community needs resulted in plans for a 6,000+/- square foot childcare center designed on the MLF property. The center will be constructed by the Town. Space was also set aside for an outdoor amphitheater, a temporary dog park and expanded parking. The projects are being phased with work planned to start summer 2023. Longer-term plans include a small housing development in place of the dog park. These projects demonstrate what we can accomplish for the community when we leverage resources, engage partners to meet common goals, address expressed community needs and expand services and programs.



OPENING OF NEW SOLID WASTE TRANSFER STATION

Benton Crossing Landfill, operated by Mono County, closed permanently on December 31, 2022. In preparation for this closure, the Town worked closely with Mammoth Disposal to ensure that the new solid waste transfer station would be open and operational prior to the closure. The transfer station is able to accept many items previously taken to Benton Crossing. It also includes a new Material Recovery Facility (MRF) and buy back center with installation of a new sort line to make recycling operations more effective and efficient. The new buy back center will be operational in 2023. All solid waste is hauled to Russel Pass Landfill in Fallon, NV.



MONO COUNTY AND TOWN OF MAMMOTH LAKES LAUNCH READY MONO EMERGENCY PREPAREDNESS PORTAL

READY Mono (READY.Mono.ca.gov) is designed to provide residents and visitors with emergency readiness, response, and recovery resources, and share real-time information and critical updates before, during, and after an emergency or natural disaster.

Sign Up for Emergency Alerts: Mono County utilizes a cloud-based, public alerting and residential safety tool that allows government agencies to send geo-targeted urgent alerts to subscribers.



Enable Your Smartphone for IPAWS: The Integrated Public Alert & Warning System (IPAWS) is the Federal Emergency Management Agency's integrated wireless emergency alert and warning system.



Find Your Zone: Zonehaven is an interactive app-based software system that provides real-time updates on local emergencies to communicate with targeted communities as it relates to evacuation orders.

POLICE PROGRAMS

MAMMOTH LAKES POLICE DEPARTMENT AWARDED OFF-HIGHWAY VEHICLE GRANT

The Mammoth Lakes Police Department (MLPD) was awarded a \$51,177 grant from the State of California Off-Highway Motor Vehicle (OHMVR) Division for the 2022 grant cycle. The MLPD applied for this funding to continue the agency's Off Highway Vehicle (OHV) program, which was launched in 2021 with its first OHMVR Division grant award. The goal of the OHV program is to provide safety and education for both residents and visitors and to reduce intrusions into the wilderness and other protected areas. OHV law enforcement protects public safety by patrolling trails that are shared with other outdoor recreation enthusiasts. Officers enforce speeding, driving while impaired, green sticker registration, encroachment/trespass issues in addition to offering accident support and more. These patrols are conducted by either the MLPD's Polaris RZR or by snowmobile. The areas surrounding Mammoth Lakes continue to see a significant increase in dispersed camping. Dispersed campers often have illegal fires that pose a great risk of causing a wildfire. MLPD continues to support our allied agency's OHV programs, which are critical to the safety and education of the public and off-road enthusiasts.



MLPD PURCHASES DRONE

The MLPD purchased a professional DJI Matrice 30T Drone to further enhance MLPD's mission of the protection of lives and property. Unmanned Aircraft Systems (UAS), more commonly referred to as drones, have proven to be a valuable resource for law enforcement, first responders, and during emergency operations. The MLPD currently has two licensed UAS operators and the drone has already been deployed in a few operations including missions to locate dispersed campers with reported illegal fires or located in "no camping zones", to assist another local law enforcement agency with a high-risk warrant, and to take aerial photos after traffic collisions to assist with accident scene reconstruction.



MLPD CONTINUES COOPERATIVE LAW ENFORCEMENT AGREEMENT WITH THE USDA FOREST SERVICE – INYO NATIONAL FOREST

The MLPD signed a three year Cooperative Law Enforcement Agreement with the USDA Forest Service – Inyo National Forest contracting for patrol services within the Forest Service’s jurisdiction. These vehicle patrols are conducted during the summer months in Shady Rest, the Mammoth Lakes Basin, and Minaret Vista, with the Town getting reimbursed for these services. The agreement

also allows for equipment purchases, up to 10% of the \$9,000 allocated. The USDA Forest Service also awarded MLPD an additional \$7,000 for patrols occurring in 2022, bringing the total to \$16,000. The agreement allows MLPD Police Officers to drive through, respond to calls, issue tickets, or move along bears in these areas when they are technically outside of the Town Limits.



MLPD AWARDED TOBACCO GRANT

MLPD was also selected to receive \$344,273 in State funding from the California Department of Justice Tobacco Grant Program, with a start date of January 25, 2022. This competitive grant is authorized under the California, Research and Prevention Tobacco Act of 2016 (Proposition 56) and provides program funding to the MLPD for the next three years. The program supports local law enforcement agencies in educating minors about the harms of tobacco products, enforcing state and local tobacco laws, and conducting retailer enforcement.

ACTIVE SHOOTER AND TACTICAL CASUALTY CARE TRAINING

The MLPD conducted a multi-agency Active Shooter/Tactical Casualty Care training exercise in August 2022, at Mammoth Elementary School. This exercise focused on emergency response to an active shooter incident on campus and how to

best collaborate and respond to this scenario with local and state emergency responders. A simulation of the law enforcement response to an active shooter helps to assure a coordinated, timely and effective response.

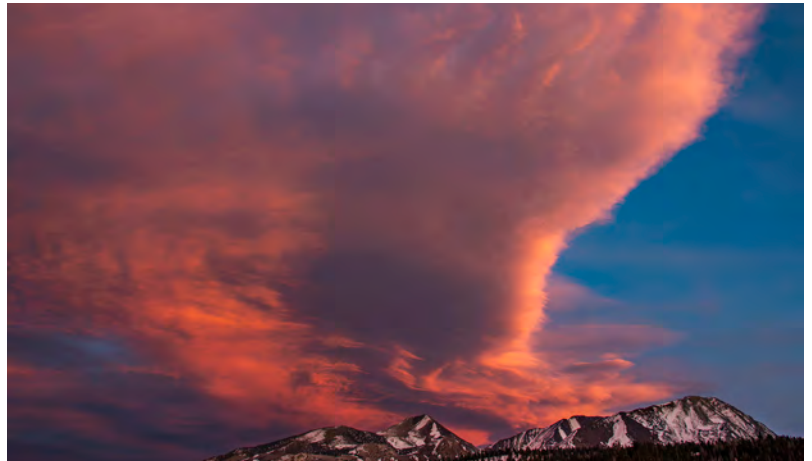
